## 1 PURPOSE

This report details the consultation undertaken by Ferrovial Gamuda Joint Venture (FGJV) to obtain community agreement for out of hours (OOH) operation of the Project Asphalt (AC) Batch Plant between 6:00PM to 7:00AM Monday to Friday, and/or 1:00PM to 6:00PM Saturdays. The agreement period is up to mid-2027.

This report has been prepared in accordance with EPL Condition E1.3 as detailed in Table 1 below.

### 2 PROPOSED OOHW

In accordance with EPL Condition E1, FGJV has sought community agreement from noise sensitive receivers to operate its AC batch plant near North Boambee Road between the following hours where required to support paving operations:

- 6:00PM to 7:00AM Monday to Friday, and/or
- 1:00PM to 6:00PM Saturdays

Activities associated with the operation of the AC batch plant include:

- Front end loader loading the batch plant hoppers with required aggregate and materials to produce AC
- Lighting towers and crib facilities
- AC trucks entering and existing site via North Boambee Road

### 2.1 JUSTIFICATION

In some instances, pavement works are required to be completed OOH due to ROL restrictions on the Pacific Highway (as approved in accordance with EPL Condition L6.5) or where a Community Agreement is in place (as approved in accordance with EPL Condition E1.1).

The purpose of this community agreement is to compliment the above OOH pavement works with the production and supply of the AC provided by the Project batch plant. It is advantageous to use the Project batch plant over Boral's AC Coffs Harbour Plant for the following reasons:

- It has higher capacity output which will provide greater certainty to meet critical ROL timeframes
- There are a number of speciality AC mix designs that will only be produced by the Project batch plant

## 3 NOISE SENSITIVE RECEIVERS

A detailed noise impact assessment of AC batch plant operations was undertaken using the Project's Noise Model Noisecheck to identify noise sensitive receivers predicted to experience noise levels above the daytime OOH noise management level (NML) and agreement would need to be sought from. A copy of the Noise Assessment Report is included in Attachment A.

Several residential receivers shown in the Noisecheck report contained in Attachment A have been removed from the receiver list given they have been either demolished, not built yet (e.g. future Lakes Estate development) or are not residential properties following ground truthing. Three additional residential properties that were not identified in Noisecheck Report were also added given their proximity to works as well as other affected residents.

Following this ground truthing exercise, a total of 73 residential receivers were identified as noise affected for the proposed OOH batch plant operations and agreement was sought from them.

Predicted noise impacts are summarised in Table 2 and a more detailed breakdown at each receiver address is provided in Attachment B.

### 4 CONSULTATION SUMMARY

All 73 noise sensitive receivers were emailed and/or letterbox dropped a copy of the letter detailing the Project's request for community agreement as a first attempt to make contact (refer to Attachment C). This written agreement also formed the script used during the consultation and included the following details:

- Description of the different construction activities proposed consistent with Section 2 above;
- Proposal for OOH AC Batch Plant Operations between 6:00PM and 7:00AM Monday to Friday, and/or 1:00PM to 6:00PM Saturdays where required
- · Map showing the location of the proposed work;
- Summary of the noise levels predicted consistent with Section 3 above;
- List of plant and equipment to be used for the work;
- Mitigation measures to minimise impacts;
- Receiver's ability to withdraw agreement at any stage during the work;
- Ongoing consultation process to ensure continuation of agreement throughout the program of work;
- Other out of hours work in the area:
- Project contact details.

Following resident feedback and concerns, the FGJV and TfNSW Community Team held two Community Information Sessions for residents on 25 February 2025 from 10am to 11am and 5:30pm and 6:30pm. Invites to the Information Sessions were letterbox dropped on Friday 21 February 2025, to all noise affected residents. Approximately, 35 residents attended the sessions, and we received 5 agreements whilst there.

Key themes included hours of operation, truck movements, discussions around the construction of the noise wall between Highlands Estate and the alignment, and residents not receiving At House Noise Treatment. FGJV advised that construction of the noise wall would commence in March 2025 with completion expected in July 2025 and also advised the team would investigate the option of trucks using the alignment from North Boambee Road to the Englands Road Interchange once safe to do so.

Follow up phone calls, emails and door knocks were also made in second and third attempts to contact all residents.

Where a doorknock was made and the resident was not home, a sorry we missed you card was left asking the resident to get in contact with the Project Team to discuss the community agreement.

The letter requesting consideration of the proposal expressed that a non-response would be considered as agreement to the project's proposal to operate the AC batch plant OOH.

## 5 COMMUNITY RESPONSE & CONSENT RATES

During the consultation period, the FGJV Community team made contact with 48 percent of the noise sensitive receivers (35 residents). Despite three attempts to make contact using a range of communication methods, 52 percent did not formally respond (38 residents). As detailed in the agreement letter in Attachment C, a non-response is considered to be agreement to the proposal.

As detailed in Table 3, formal agreement to undertake proposed OOH for both nighttime and Saturday daytime was 30 percent, 3 percent agreed only to Saturday daytime, and 15 percent did not agree. Of the 35 residents who did formally respond, 63% of residents did provide their agreement which constitutes a substantial majority, and another 6% agreed to Saturday daytime only.

Copies of the signed agreements will be submitted to the EPA along with this report.

A more detailed breakdown of the consultation undertaken with each receiver and their response is provided in Attachment B.

# Re: Agreement to work outside of approved construction hours at the Coffs Harbour bypass temporary Asphalt Batch Plant on North Boambee Road

Dear Resident

The Australian and NSW Governments are investing in the 14-kilometre Coffs Harbour bypass project. The bypass will boost the regional economy and improve connectivity, road transport efficiency and safety for all motorists.

The Coffs Harbour bypass has built a temporary asphalt batch plant on North Boambee Road. This plant will only provide asphalt for the project and will be removed after the bypass construction is completed. We have provided a map to show the location of this work.

As part of major construction, the project team is seeking your agreement to operate this plant outside of approved construction hours until mid 2027. These operations will be Monday to Friday from 6pm to 7am and/or Saturday from 1pm to 6pm, when required.

Our approved construction hours are from Monday to Friday from 7am to 6pm, and Saturday from 8am to 1pm.

Under project's Ministerial Conditions of Approval, the project team can work two nights and then provide a night of respite. We can also seek agreement from noise impacted community members to not provide respite and work outside of approved construction hours. The project is required to have agreement from a substantial majority to progress with these activities.

#### **Noise levels**

The noise you are likely to hear during these activities includes the asphalt batch plant operating, a front end loader, light towers and asphalt trucks entering and leaving site via North Boambee Road.

The predicted noise level for this work is moderate to noisy. To help explain this, we have included a diagram of comparative noise levels.

The project's Minister's Conditions of Approval (MCoA) sets strict requirements for work outside of standard construction hours and noise, vibration and dust management. To ensure compliance and mitigate impacts of this out of hours work, we:

- Consult and seek agreement with directly impacted residents ahead of the work starting
- Monitor noise levels, dust and vibration
- Use water carts, and soil binders to reduce dust where possible, focusing on high traffic areas within the project boundary
- Turn off plant and machinery when not in use
- Use non-tonal reversing beepers and instruct workers to keep noise to a minimum
- Position plant and equipment as far from nearby neighbours as possible.

Further agreements may be required for future work in the area, separate agreement will be sought, if required.

### Other out of hours work in this area

- Delivering machinery using the project's approved heavy vehicle routes
- Carrying out survey, geotechnical and pavement investigations, including some out of hours work
- Maintaining and refuelling plant and machinery and maintaining internal project haulage routes
- Maintaining environmental controls and internal haulage routes, including some out of hours work
- Delivering, laying and cutting concrete and asphalt.

### Seeking your agreement

This program of work is a proposal we are seeking your agreement for. You are under no obligation to sign these agreements. By signing this document, you confirm that you agree to one or all of the programs of work between February 2025 and mid 2027 as outlined in this letter.

We will make three attempts to contact you about this agreement. Please note that if we do not receive a response from you by **9am on Friday 28 February 2025**, we will consider this as agreement to our proposal. At any point you can withdraw this agreement by contacting the project team.


